## **E- TRANSFER PAYMENTS TO C.V.R.A.**

### **To: Send money using Interac E-Transfer**

1. Log onto your online or mobile banking app and select the account you want to transfer money from.
2. Add the Recipient as Columbia Valley Ratepayers Association (C.V.R.A.)
3. Add the CVRA eMail **info@columbia-valley.ca**
4. Enter the amount and a security question
5. (no need if the recipient has registered for Interac e-Transfer<sup>®</sup> Autodeposit which CVRA has done).
6. The amount will automatically be put into the C.V.R.A. Account.
7. Enter that the payment is for CVRA Membership for year .....

## **REMITTING THE MEMBERSHIP FORM BY EMAIL**

1. Fill in the Membership Form (PDF FORMAT) if you have the appropriate app ) then save for your copy.
